

GARIS PANDUAN PERMOHONAN PENETAPAN TARikh KUATKUASA BAGI GALAKAN ELAUN CUKAI PELABURAN

*Guideline to Apply for the Determination of Effective Date of
Investment Tax Allowance Incentive*

PENGENALAN

Introduction

Garis panduan ini adalah untuk memberi penjelasan mengenai prosedur dan syarat-syarat yang perlu dipatuhi bagi permohonan penetapan tarikh kuatkuasa galakan Elaun Cukai Pelaburan yang diluluskan di bawah Akta Penggalakan Pelaburan 1986 dan galakan yang diluluskan di bawah Seksyen P.U.(A) 113, Akta Cukai Pendapatan, 1967.

The purpose of this guideline is to explain the required procedures and conditions that must be adhered to for applications in determining the effective date of the Investment Tax Allowance incentive approved under the Promotion of Investments Act, 1986 and incentive approved under Section P.U.(A) 113, Income Tax Act 1967.

Kelulusan Galakan Elaun Cukai Pelaburan adalah berkuatkuasa mulai dari tarikh perbelanjaan pertama modal yang layak dilakukan oleh syarikat. Syarikat yang telah diluluskan Elaun Cukai Pelaburan di bawah Akta Penggalakan Pelaburan, 1986 tetapi tarikh kuatkuasa galakan belum ditetapkan hendaklah memohon untuk penetapan tarikh kuatkuasa galakan

The approval for the Investment Tax Allowance incentive is effective from the date of company's first qualifying capital expenditure incurred. A company which has been approved for the Investment Tax Allowance under the Promotion of Investments Act, 1986 but the effective date of the incentive has not been determined is required to apply for the determination of effective date of the incentive.
